Subject: Accreditation / Moral Support Procedure "Academic, professional training credits" for seminars, workshops, stag /training or competitions with educational purposes pursuant to art. 4.2 a) EurEthICS ETSIA Statute, organized by Training Centre (TC), Association, School, Academy or Coordination Centre of ETSIA registered associations / schools / academies

Following the decision of the EurEthICS ETSIA Board of Directors of 09/04/2018 amended today, the organising committees (TC, Associations, Schools, Academies registered EurEthICS ETSIA) are informed that the procedure for requesting collaboration with EurEthICS ETSIA and related moral support, to be sent to info@etsia.eu, must include a description of the following points (indicative model of request in Annex 1):

1. Request for collaboration, granting of patronage and use of the EurEthICS ETSIA logo (and / or related e.g. ETSIA Karate Shotokan) indicating the purpose of the seminar / workshop or meeting / training or competition, programme and/or reference regulation in compliance with the EurEthICS ETSIA as per the 2020-2021 Guidelines;
2. Request for administrative assistance from the General Secretariat during the preparatory phase (relations with competent institutions and authorities, registration of the event on the EU Experts or Official Partner #BEACTIVE #HealthyLifestye4All Initiatives of the European Commission; verification and insurance coverage of the event and of all participants);
3. Request or confirmation of the presence of EurEthICS ETSIA certified teachers, referees and / or coaches (or from other bodies or organizations with a mutual recognition protocol with EurEthICS ETSIA) according to the EQF reference system, to ensure the quality of the seminar / workshop or meeting / training or competition, indicating the needs and the reference training programme of the learners (athletes, teachers, referees and related EQF levels and skills);
4. Request for EurEthICS ETSIA Certificates and / or Qualification Certificates or Training Credits according to the procedures and quotas specified in the EurEthICS ETSIA guidelines;
5. Request for supply of official EurEthICS ETSIA materials (flags, banners, etc.).

Seminars, stages, competitions and internships with special, environmental, social inclusion and in any case EurEthICS ETSIA statutory purposes are subject to a simplified procedure.
